Litter _____





Dear Resident

I am writing to update you in relation to certain developments on Dún Laoghaire / Rathdown County Council since my last newsletter in November.

High Rise Developments _____

Concern has been expressed in many quarters at high rise developments in the County. This concern has been reflected in a number of recent decisions by An Bord Pleanála. The Bord has overturned a number of decisions of the Council to grant permission for high rise developments at certain locations in the County.

I agree with these decisions of the Bord.

The Council is currently undertaking a study of high rise buildings generally and this study together with the upcoming review of the Council's housing strategy provides an opportune moment to confront this issue. While acknowledging the need for a reasonable increase in height and density, there is a clear public demand for the imposition of stronger and clearer controls over high rise buildings particularly in existing and settled low-level residential areas.

I also welcome the recent decision of the Council to refuse permission in respect of the application to develop the Europa Mazda site in Blackrock. The planners had particular regard to the protected structures in the vicinity of the site and the negative impact on the residential amenity of adjacent properties.

Blackrock Park _____

The Council is to install a small car park opposite Phoenix Terrace for visitors to Blackrock Park. This measure will facilitate improved public access to this amenity.

Airfield

As you may be aware the Fianna Fáil group on the Council recently submitted a motion to change the zoning on part of the lands at Airfield from residential zoning to open space in order to safeguard these lands as a public amenity. Unfortunately our motion was opposed by the other parties on the Council and was defeated. We remain committed however to pursuing whatever avenues are open to us to protect this important community asset.

Libraries _____

There was good news for libraries in the recently adopted Council budget for 2006. Provision was made for the purchase of new books in the sum of €475,000.

In the recently unveiled five year programme for the library service commitment was made to retain and develop Deansgrange Library. €200,000 is to be spent on improving the library service there.

Graffiti _____

I have pursued this issue over the last year. I am pleased to advise that increased provision has been made in the 2006 budget for the removal of graffiti. Hopefully in the months ahead we will see a more systematic approach on the part of the Council to the removal of graffiti.

Special Speed Limits _____

The Council is to roll-out special speed limit zones in the vicinity of schools over the coming years. These special speed limits will operate at certain times during the day and during the school term. It is intended that a pilot scheme will be operated at a location in the County later on this year. The Council will use the results of this scheme to formulate a policy framework for the operation of these zones throughout the County.

Monkstown Ring Road _____

The oral hearing into the proposed Monkstown Ring Road was recently completed. Many residents made submissions. Particular concerns were raised in relation to noise and vibration, road safety and the impact on air quality. It is imperative that these issues are satisfactorily addressed by An Bord Pleanála.

Foxrock Avenue and Hollypark _____

I welcome the recent upgrading of the ramps on Foxrock Avenue and Hollypark. These works follow representiations by the local residents' association in conjunction with the local Councillors.

Pay by Weight _____

The recent budget while increasing the pay by weight charge made no increase in the standing charge or the lift charge. This is consistent with the Council's policy of encouraging recycling. In 2005 usage of green bins increased by 25%. I would like to take this opportunity to commend households in the County who have made such an important contribution to recycling in recent years.

Blackrock Baths _____

The Blackrock Baths Site and the surrounding lands remain derelict and under developed with the result that this entrance to Blackrock is dilapidated and unsightly. I would like to gauge public enthusiasm for its development. With that in mind I would be interested to hear any suggestions that residents may have for the development of this area.
